As awarded by the Court and taxed and allowed by the Taxing Master.

1.1.4. DISBURSEMENTS

A maximum of R1 000-00 for necessary disbursements, or such other amounts as the Company may agree to in writing from time to time. Travelling costs will be reimbursed at a rate of R2-50 per kilometre up to a maximum distance of 300 kilometres.
