Any inheritance of any heir/legatee who, as at the date of accrual of the inheritance shall not yet have attained the age of twenty one, shall be paid and delivered to my administrators in trust who shall hold and administer such inheritance for and on behalf of such heir/legatee subject to the following conditions:

- i. My administrators shall be entitled to apply so much of the income and if the income is insufficient, so much of the capital of each trust as they in their discretion may deem fit, towards the maintenance of the beneficiary/ies of the trust concerned. Without affecting the generality of the foregoing, my administrators shall be entitled to make advances to such beneficiary from his/her trust for the purpose of enabling him/her to set up a home and/or in order to establish or acquire a business or pursue a profession or other calling and for the purpose of supplementing his income and /or for any other purpose as my administrators may in their sole and absolute discretion deem fit.
- ii. Any income which is not paid by my administrators to the beneficiary of the trust concerned shall remain vested in such trust.
- iii. My administrators may in their discretion award the whole or any part of the capital of any trust to the beneficiary thereof in advance of the time it would otherwise have vested in him, if they are of the opinion that such award is warranted by circumstances.
