Consent for the use of Personal Information

I understand that in order for the LEZA Group and its subsidiaries to positively verify my identity for the purposes of obtaining a Government Payroll Deduction, applying for insurance, normal Membership alteration, or claims processing, my Personal Information must be accessed.

I also understand that the LEZA Group and LegalWise South Africa (RF) (Pty) Ltd, as a subsidiary of the LEZA Group may verify my identity either through a method of asking questions pertaining to my Personal Information or by using biometric verification solutions. My answers or biometric data will be shared with the Authorised Verification Agent, who will confirm whether the verification is correct or not. LegalWise South Africa (RF) (Pty) Ltd will not see or receive the correct answers to the verification questions, and will receive a final positive or negative verification from the Authorised Verification Agent.

I hereby authorise the LEZA Group and LegalWise South Africa (RF) (Pty) Ltd and its duly Authorised Verification Agent, to access my Personal Information and conduct background screening checks.

I consent to requests for consumer credit information to be released for fraud prevention or detection purposes.

I acknowledge that any Personal Information supplied to the LEZA Group and any of its subsidiaries is provided voluntarily and that the LEZA Group and its subsidiaries may not be able to comply with its obligations if the correct Personal Information is not supplied.

I understand that privacy is important and that reasonable efforts are in place to ensure that any Personal Information in possession or processed is kept confidential, stored in a secure manner and processed in terms legislation and for the purposes I have authorised.

I warrant that all information supplied is accurate and current and agree to correct and update such information when necessary.

By submitting any Personal Information to the LEZA Group, its subsidiaries and/or Responsible Party in any form, I acknowledge that such conduct constitutes a reasonable unconditional, specific and voluntary consent to the processing of such Personal Information in the following manner by the Responsible Party and/or verification information suppliers:

> Personal Information may be shared with the Verification Information Suppliers for verification or other legitimate purposes and be stored for a reasonable period by the Responsible Party and/or the Verification Information Suppliers.

If the Responsible Party utilises the Personal Information contrary to the Privacy and Data Protection Conditions, I may first resolve any concerns with that Responsible Party. If I am not satisfied with such process, I have the right to lodge a complaint with the Information Regulator. I agree to indemnify the Responsible Party, and Verification Information Suppliers, acting in good faith in taking reasonable steps to process my personal information lawfully, against any liability that may result from the processing of my personal information. This includes unintentional disclosures of such personal information to, or access by unauthorised persons, and/or any reliance which may inadvertently be placed on inaccurate, misleading, or outdated personal information, provided to the LEZA Group and any of its subsidiaries by myself or by a third party in respect of me.

I understand that it is a condition of Responsible Party's verification information suppliers that this information is furnished by them solely for the purposes of verifying my credentials.

I agree that this consent and indemnity declaration remains valid for all current and future personal credential verification requests by WHOYOU (PTY) LTD, as an Authorised Verification Agent.
